## 1. INTRODUCTION

Langur Burja is a purely client-side, simulated gambling game created and published by DStudios Nepal (“we”, “us”, “our”). We take your privacy seriously. This Privacy Policy describes in detail what information Langur Burja stores, how it is used, and what control you have over that information. By installing or using Langur Burja, you agree to the terms of this Policy.

## 2. SCOPE

This Policy applies only to Langur Burja as made available by DStudios Nepal. It does not apply to any other games, websites, services or products offered by us or any third party, even if linked or mentioned within Langur Burja.

## 3. DEFINITIONS

“Local Preferences” means user-chosen settings and progress data stored on your device.

“Game Data” means your in-game virtual coin balance, progress checkpoints, and display name.

## 4. INFORMATION WE STORE

### 4.1 TYPE OF DATA

- Username: the display name you choose upon first launch of the game.
- Game-Coin Balance and Progress: the number of virtual coins you have and any level or stage progress.
- Other Preferences: any sound, display or control settings you adjust in the game’s options menu.

### 4.2 STORAGE LOCATION

All data is stored locally on your device (e.g., in application storage or local save files). No information is transmitted to our servers or to any third party.

## 5. HOW WE USE YOUR DATA

### 5.1 GAME FUNCTIONALITY

- To remember your chosen username every time you open the game.
- To load and save your virtual coin balance and level progress between play sessions.
- To apply any preferences (such as sound volume or display mode) you have selected.

## 5.2 NO OTHER USES

We do not use your data for advertising, analytics, marketing, behavioral profiling, or any form of personalization beyond reloading your last-saved state.

## 6. NO DATA COLLECTION OR SHARING

### 6.1 NO ACCOUNT REGISTRATION

You are never required to create an account, log in, or provide contact information.

### 6.2 NO DEVICE OR NETWORK DATA

We do not collect or record your IP address, device identifiers, hardware model, operating system version, crash reports, or any form of network or location data.

### 6.3 NO THIRD-PARTY SHARING

Because no information ever leaves your device, there is nothing we can share, sell, rent, or disclose to any third party—ever.

## 7. DATA RETENTION AND DELETION

### 7.1 RETENTION PERIOD

Your saved data remains on your device indefinitely until you choose to delete it or uninstall the app. We maintain no copies of your data on our servers.

### 7.2 DELETION OPTIONS

- Uninstall the game: removes all local data.
- Clear app data (via your device's settings menu): resets the game to first-launch state.

## 8. YOUR RIGHTS AND CHOICES

Since no personal data is transmitted or stored by DStudios Nepal, there are no external data flows requiring opt-in or opt-out. To manage your information, simply clear your app data or uninstall.

## 9. CHILDREN'S PRIVACY

Langur Burja is rated for adults aged 18 and above. We do not knowingly target or store any information for users under 18. If you are under 18, you should not download or play this game.

## 10. SECURITY

All saved data resides on your device. We recommend you use your device's built-in security features—such as PINs, passwords, or biometric locks—to protect your privacy.

## 11. THIRD-PARTY CONTENT AND LINKS

Langur Burja contains no advertisements, no SDKs, and no external links of any kind. All content and functionality are self-contained.

## 12. CHANGES TO THIS POLICY

We may update this Privacy Policy to reflect changes in our practices, applicable laws, or game functionality. Whenever we make material changes, we will update the “Last Updated” date at the top. Continued use after updates constitutes acceptance.

## 13. GOVERNING LAW
